Membership Application

___ Regular membership. Regular members must live in Texas County, Missouri, or one of its adjoining counties. Regular members are allowed to vote on matters pertaining to the club.

___ Associate membership. Associate members are those who live anywhere outside of Texas County, Missouri, or one of its adjoining counties, active duty military, or sworn law enforcement. Associate members are allowed full use of the club facilities, the same as regular members, but are not allowed to vote on club matters. Sworn law enforcement officers in Missouri will be issued associate membership cards for no fee upon approval by the Board of Directors.

___ Junior membership. Junior members are those 17 years of age and younger. Junior members are not allowed to vote on club matters. \$20.00 to join and for annual renewal.

First year membership: \$80.00. Annual renewal: 61 years and younger - \$75.00, 62 years and older or active duty military - \$55.00. Five year renewal: \$300.00. Lifetime membership: \$750.00. Note: All memberships run Jan 1st through Dec 31st. Renewal dues are due on Jan 1st. Former members must resubmit a new membership application to rejoin.

RANGE RULES

1. No glass objects of any kind are to be used as targets.
2. Pick up and dispose of, or take with you, any items that you brought to the range, especially those items used as targets. Help keep the ranges clean and presentable.
3. Pick up and dispose of your empty shell casings.
4. Use common courtesy and sense when sharing the ranges with others.
5. You are responsible for the behavior of any guests you bring to the ranges.
6. Ensure that your weapon's chamber is empty when someone is down range.
7. Be aware of the direction your muzzle is pointing.
8. Please report to any member of the board any person(s) who deliberately damages club property, conduct themselves in a manner that physically endangers others, is very offensive to others, and/or allow their guests to do so.
9. The consumption of alcoholic beverages of any kind, or use of illegal drugs, on club property is prohibited.
